Minutes of a meeting of the **PLANNING & HIGHWAYS COMMITTEE** held on **Monday 4<sup>th</sup> February 2019** in Telscombe Civic Centre at 7.30 pm.

## **2313. PUBLIC QUESTION TIME**

A resident present asked why the press and public were to be excluded from Agenda Item 13 'To consider Bridleway 8 Gate key holder application'. The Committee responded that due to the recent General Data Protection Regulation (GDPR) on privacy for individuals, the Council were now no longer able to openly discuss these applications, as it includes applicant's names.

## **2321. ESCC STREET LIGHTING MAINTENANCE AGREEMENT 2019/2020**

The Amenities Officer reported that the ESCC Highways Team currently maintain the Town Council's street lights and that the yearly maintenance agreement is subject to its yearly review in April. There are no changes to the current rates of £25 per street light x 26 street lights. It was proposed by Cllr Harris, seconded by Cllr Sharkey and unanimously **RECOMMENDED** that the agreement is signed by the Town Clerk for the continued maintenance of the Town Council owned street lights.

Tree Planting Scheme – The Amenities Officer confirmed that Burley’s have quoted £25 per tree for the planting and stake. EH Treecare have offered to provide the works for free. The Amenities Officer suggested that we look to book the works for next November, as the trees need to be planted within a certain time period which has now passed. She will make further investigations and report back to the Committee.

Damaged street light column – The Amenities Officer reported that she has been unable to check if the column had been fixed due to the works taking place at the properties behind the column. Cllr Wilkins confirmed that another light column had also been damaged in similar circumstances in Fairlight Avenue. It was agreed that the Amenities Officer would report this further issue to ESCC Highways.

Urgent Matters (overgrown brambles between Telscombe Grange and Smugglers Rest) – Cllr Armour asked the Amenities Officer to bring a map to the next meeting, detailing who owns which section of land.

Community Speedwatch Telscombe Village – Cllr Wilkins confirmed that she was unsuccessful in her request to reduce the speed limit in the village to 20mph.

## 2322. Action List (Contd)

Peacehaven and Telscombe Neighbourhood Plan – The Amenities Officer informed the Committee that the date for the next meeting had changed to Monday 11<sup>th</sup> February.

Notification of Planning Results – Cllr Robinson requested that this item is kept on the Action List for the next meeting, so that the Amenities Officer can report if the applications are being handled more effectively.

Urgent Matters (roof tiles placed on the grass outside 11 The Esplanade) – The Amenities Officer informed the Committee that the tiles have been removed but she will continue to assess this area weekly. Cllr Wilkins confirmed that a resident had complained about fly tipping in this area at the last Councillors' Surgery, and that she believes their complaint relates to this issue. Cllr Armour asked the Amenities Officer to find the original planning application and bring it to the next meeting so that the Committee can look at the possibility of contacting Lewes District Council in relation to the current work practices being undertaken for this development.

Urgent Matters (rubbish behind bank of shops on the South Coast Road) – the Amenities Officer confirmed that she had checked the area on 1<sup>st</sup> February, following the bin collection, and that the refuse had been picked up. However, there appears to be a lot of rubbish spilling out into the road from the garden of one of the shops which is a food outlet. It was agreed that the Amenities Officer would report this to Environmental Health.

## 2323. URGENT MATTERS AT THE DISCRETION OF THE CHAIRMAN FOR NOTING

Cllr Robinson reported that she had been contacted by a resident, asking that a bus shelter is added to the bus stop at Bannings Vale, at the corner of Ifield Close. The Amenities Officer confirmed she would contact Lewes District Council but believes this would not be granted as only one bus route currently serves this stop.

Cllr G Maskell stated that a truck has been parked on the grass verge at the bottom of Telscombe Cliffs Way for approximately a week, and appears to have been abandoned. It was agreed that the Amenities Officer would report this via Operation Crackdown.

Cllr G Maskell also confirmed that another sign on the railings at the bottom of Telscombe Cliffs Way had partially come away and was lying down flat on the pathway, thus causing an issue for pedestrians. The Amenities Officer would investigate this and report accordingly.

Cllr G Maskell further requested that the car parks at Central Avenue and Fairlight Avenue should be advertised via social media. The street parking by the school and The Esplanade is increasing and it may assist in bringing other options to the attention of car owners.

## 2324. EXCLUSION OF PRESS AND PUBLIC

It was unanimously **RESOLVED** to exclude the Press and Public from the meeting during consideration of the following items pursuant to section 1 (2) of the Public Bodies (Admissions to Meetings) Act 1960, on the grounds that publicity would be prejudicial to the public interest by reasons of the confidential nature of the business to be transacted.
