Lewes DC **APPROVE** planning permission for the application subject to a condition requiring that the external materials match those of the existing house.

Telscombe Town Council considered the original application and **OBJECTED** to the proposal due to the unsympathetic materials and the impact of the wooden clad extension on the neighbouring dwelling.

LW/16/0949 34 Nutley Avenue E. Saltdean BN2 Application for hip to gable roof extension and installation of 3 front and 1 rear dormer.

Lewes DC **APPROVE** the application subject to conditions requiring details of dormer cladding to be submitted to local planning authority, external materials to match and construction work hours to be limited.

Telscombe Town Council considered the application and **SUPPORT** the proposal subject to conditions requiring matching materials, limit on construction hours and deliveries to be made after 9.30am due to traffic congestion and air pollution.

Lewes DC APPROVE the application subject to conditions for materials to be approved prior to commencement, hours of construction work restricted, no windows or doors to be inserted on western elevation, a Construction Environment Management Plan to be approved setting out all arrangements for traffic, deliveries of construction materials, temporary site security fencing, artificial illumination, noise, dust, air pollution etc.

Telscombe Town Council considered the application and **SUPPORT** the proposal subject to conditions setting out the delivery of materials, repair of highway and restriction on hours of working.
