Planning Application for conversion of existing bungalow to four studio flats to side extension, demolition of garage and addition of second floor (variation of application LW/16/0842) to include full height external walls.

Lewes DC **GRANTS PERMISSION** for the application subject to nine conditions including, samples of all external materials to be approved. Details of ground levels together with eave and ridge heights to be approved by the LPA. Details of parking layout to be approved. Boundary treatment to be approved. Construction Management Plan setting out dust suppression, location of plant and materials storage. Restricted hours of construction working. First floor level windows to rear to be obscure glazed and non opening unless top openers above 1.7m from floor level used.
